### Quick guide to Covid-19 personal protective equipment (PPE) and face covering requirements

#### Adults and Children's Social Care (excluding education and early years)

Version 1.5 (20 August 2021)

##### Scope:

- All Derbyshire County Council residential, home care and commissioned adults and children's social care services.

##### PPE requirements:

PPE should be worn according to this guide whether you are providing care within an establishment or the client's home or supporting them outside the home (for example, a visit to a family member, a walk in the park or a visit to the shops or a cafe).

The contents of this guide meet the minimum requirements for PPE in the relevant government guidance and supplemented by Derbyshire County Council public health advice and risk assessments. This document should be read in conjunction with the COVID-19 Personal Protective Equipment (PPE) Guidance which is available on the Our Derbyshire [Personal Protective Equipment](#) webpage.

Please note that this guide only refers to PPE needed to be worn specifically during the Covid-19 pandemic. Appropriate PPE previously worn for all other purposes should continue to be worn as normal.

All used PPE should be disposed of safely according to DCC guidance.

##### PPE usage definitions:

- Single use – Used for interaction with one client only. Item is discarded after the interaction is finished.
- Sessional use – Used for one session only and then discarded:
  - In residential/day care settings – a 'session' is the time working between breaks up to a maximum of 4 hours (masks worn on a sessional basis must be changed if the time between breaks is more than 4 hours)
  - In home care/community settings – a 'session' is the time spent interacting with one client

##### Notes:

1. Visors – Visors are worn for any task where there is a risk of splashing in the eyes and always for aerosol generating procedures (AGPs) and where indicated in the Tables. A visor should be worn for the duration shown in the table unless heavily contaminated. Contaminated visors should be discarded and replaced after completing the interaction with a client or other intervention.
2. Goggles – Goggles are available for those unable to wear visors for medical reasons. Managers should obtain advice from their health and safety adviser for any staff who may require goggles for this reason, before placing an order from the Logistics Hub. Visors must be used for all AGPs without exception.
3. Face coverings - Wearing a face covering is mandatory in many indoor public spaces outside of social care settings. Some individuals are exempt from wearing face coverings. This applies to those who: cannot put on, wear or remove a face covering because of a physical or mental illness or impairment or disability; or speak to or provide help to someone who relies on lip reading, clear sound or facial expression to communicate.
